Ms. Wykoda Wang, CORE MPO staff, explained that the proposed amendment to the Transportation Improvement Program (TIP) would add the FTA funding award that CAT received for purchase of 26 paratransit vehicles.

Ms. Wang presented the draft Unified Planning Work Program (UPWP) for fiscal year 2018. She reviewed the proposed planning activities and budget, which totaled approximately \$518,000.

Staff recommended CAC endorsement of the UPWP.

5. Call for Projects for CORE MPO's Surface Transportation Block Grant (STBG) Funds

Ms. Wang informed the committee of the status of the Call for Projects for CORE MPO's Surface Transportation Block Grant (STBG) funds (a.k.a. Z230 funds). Approximately \$13 million, for fiscal years 2018-2021 could be awarded to a broad range of eligible projects.

The application window would be closing the following day. MPO staff had not received any applications, but expected some before the deadline. She explained that the TCC would score the applications this month and make their funding recommendations to the CORE MPO Board in March.

6. Update on the CORE MPO Transportation Alternatives Call for Projects

Ms. Jane Love, CORE MPO staff, reported on the status of the MPO's Call for Projects for Transportation Alternatives (TA) funding. These funds are generally for bicycle and pedestrian type projects, or certain community enhancements. As much as \$3 million could be awarded by the MPO to eligible projects.

This competitive selection process is following the same schedule as the Call for Projects for the Surface Transportation Block Grant (STBG): the applications were due the day after this meeting; the TCC would score them this month and make their funding recommendations to the CORE MPO Board in March.

So far staff had not received any applications, but was aware of some entities' intentions for applying. This report was presented for information.
