Mr. Nathaniel Panther said that the TCC had met and had endorsed the Congestion Management Process (CMP).

E. Executive Director's Report

6. Report

Mr. Mark Wilkes informed the Board members that they should see any reported inkind match reflected in their dues statements, and asked members to let him know if they find any discrepancies.

Mr. Wilkes reported that the National Association of Counties Officials is holding a peer exchange in Savannah on Thursday and Friday of this week. He will be giving a presentation about some of the MPO's work in freight planning. Tom McQueen, of GDOT Planning, also will give a presentation at the event.

Mr. Wilkes noted that adoption of the Congestion Management Process update at today's meeting will fulfill the last outstanding action item from the preliminary findings of the Federal Certification Review as expressed in the November 9th letter from Rodney Barry.

The MPO's April meetings look to have a light agenda, because the development of the new Transportation Improvement Program is expected to occur a little later this year, once the MPO receives information from GDOT. Unless we have sufficient information to prepare a draft TIP in advance of the April MPO meeting, we will likely recommend canceling the meeting. MPO staff will keep the board posted on the outlook for the April meeting.

The minutes of the Feb. 22, 2017 CORE MPO Board meeting were approved as written.

8. Congestion Management Process Update

Ms. Stephanie Rossi gave a comprehensive presentation on the process and results of the 2017 update of the CORE MPO Congestion Management Process (CMP). She covered: the purpose of the CMP; the strategies from prior CMPs that have been implemented; identification of the CMP network; types of data examined; performance measures (average travel time, average travel speed, 95th percentile travel time, and buffer index); the list of congested segments; strategies to address those; evaluation in the form of a CMP report card; future steps to improve the next CMP update; and the nature of comments received on the CMP report. As a result of the comments, she is making scrivener's edits and adding more explanations of the tables.

Staff recommended CORE MPO Board approve the 2017 update of the CMP.

There were no questions. A motion was made and seconded to approve the CMP. The motion passed with none opposed.

9. Endorsement of Funding Requests for PL Discretionary Funds

Mr. Mark Wilkes reported that MPO staff had received two proposals for the Discretionary Highway Planning (PL) Funds, which are awarded semi-annually through the Georgia Association of MPOs (GAMPO), in cooperation with GDOT Planning and the Federal Highway Administration (FHWA) Georgia Division. MPOs outside of Atlanta can submit requests for these planning funds.

The two requests that staff received were both proposals to study interchange improvements: 1) Chatham County wishes to use planning funds to study the interchange of Jimmy DeLoach Pkwy. at I-16; 2) the Savanah Airport Commission wishes to use planning

funds to study the interchange of Pooler Pkwy./Airways Ave. at I-95. Each of those agencies is committing the required local match. The deadline for submittal to GAMPO was March 13. The TCC endorsed the submittals, and MPO staff submitted them noting that the CORE MPO Board resolutions of support would be considered at this meeting on March 22. The purpose of the Board resolution in this process is mainly to confirm local match, which was already done by the partner agencies ahead of the submittal deadline.

Staff recommended MPO Board approval of the resolutions of support for the two planning study submittals to the GAMPO PL Funds Review Committee. Such a motion was made and seconded. The motion passed.

V. Status Reports

10. FY 2017 Planning (PL) Funds Budget Adjustment

Mr. Wilkes informed the Board members of a budget adjustment of the highway planning funds in the FY 2017 Unified Planning Work Program. The adjustment simply shifts some funding from certain planning tasks to other tasks, in light of some modified approaches during the first part of the fiscal year, such as carrying out the CMP update in house, which necessitated an increase in that task budget for staff to charge against. The budget adjustment does not change the overall level of funding.

This report is for transparency. No action is necessary.

Mr. Wilkes added that, due to these kinds of changes in work flow, the discretionary PL funding that GAMPO awarded last year for some CORE MPO tasks such as the CMP Update, Socio-economic Data, and TDM Strategies is not needed now, and unless the Board objects, he would ask GAMPO to return those funds to the statewide PL fund balance to be available for future planning proposal awards.

No objections were expressed by members present.

11. Federal Certification Review Status

Chairman Al Scott asked Mr. Wilkes if there was anything he'd like to say about the Federal Certification Review findings. Mr. Wilkes said that MPO staff has addressed all items in the Draft Certification Report and the MPO should receive the final report from FHWA and FTA soon.

Mr. Wilkes noted that Andy Edwards from the FHWA Georgia Division was present today.

Chairman Scott offered Mr. Edwards an opportunity to speak. Mr. Edwards said he had nothing to add at this time, but CORE MPO would be certified.

12. Report

Mr. Byron Cowart reviewed the status of numerous projects on the Pre-construction and Active Construction handouts.

B. Member Governments

13. Reports

Chatham County -- Mr. Nathaniel Panther reported that they had received environmental approval on the Truman Linear Park Trail and would begin right-of-way acquisition in the next couple of weeks.

City of Savannah -- Mr. Mike Weiner stated that the Coffee Bluff sidewalk project is complete. On Project DeRenne, the consultants are working on the scope. On the Delesseps Ave./LaRoche Ave. project, the consultants are addressing utility relocation. He noted that the City is working with GDOT on the Savannah Regional Traffic Operations Program (SRTOP), which provides ongoing monitoring of 56 signals along 35 miles, including US 17 and Victory Drive/US 80 out to Tybee Island. This is the first implementation of this program outside the Atlanta area.

City of Richmond Hill -- Representatives said a report was not necessary at this time.

C. Chatham Area Transit Authority

14. Report

Mr. Grant Sparks said that CAT is using the same AirSage data that the MPO used for the CMP to conduct an Origin & Destination study. This allows CAT to asses how the transit

routes relate to observed travel patterns. The information is broadly useful to all planners in the area.

Mr. George Fidler reported that the airport's activity is growing, including flights to Canada now, flights to the Caribbean expected soon, and flights to England and Germany after that. This means more gates, expanded security area, and expanded international processing area are planned. Repaving of Airways Ave. is starting soon. Also, the Savannah Airport, Savannah Traffic Engineering, and Pooler are installing an adaptive traffic signal coordination system on all the signals on Airways Avenue/Pooler Parkway (including the I-95 ramps) which will coordinate/synchronize all the signals along the corridor to mitigate congestion and delays. The system is scheduled go live in mid-April.
