1) Welcome

Meeting was called to order at 9:08 a.m. by Lara Hall.

2) Action Item

A. Approval of Minutes

The July 23, 2019 Meeting Minutes were approved. Motion by Holmes Bell, second by James Collins. All in attendance approved the motion.

B. Appoint Chair and Vice-Chair

Tabled - all in attendance agreed to reconsider the voting members and chair options at the next meeting.



3) Report Items

A. Budget Report – Lara Hall

The year's budget was discussed – operating in the red. Ms. Hall stated the budget listed in the agenda is only updated through June 30, 2019. Ms. Hall stated new partners such as the City of Tybee and City of Pooler are now contributing, and certain items such as Operating Supplies may be adjusted lower to compensate for other line items. Ms. Hall stated SAGIS would need at least \$10,000-15,000 additionally annually in order to be fully funded, and asked Suzanne Cooler if the County may be able to fulfill this amount. Suzanne Cooler stated she would review this request.

- B. Imagery/LIDAR Lara Hall
 - i. Ms. Hall noted the 2018 imagery has issues with color balancing and was captured in high and low tide, resulting in striped imagery. Holmes Bell asked whether the next imagery cycle would have color balance issues and differing tide levels. Ms. Hall noted Pictometry imagery is higher quality with a faster turnaround, and should avoid these in most part, and in this collection will be ³/₄" resolution which will provide rich details. Kevin MacLeod noted it is a tighter date range; i.e. over days instead of months with tighter tidal specification.
 - ii. LiDar– Lara Hall

Ms. Hall noted delivery is delayed, and it is unknown when Chatham County will receive data. Full project still stated by vendor to be delivered by July 2020.

iii. Pictometry 2020 – Lara Hall

Ms. Hall outlined the benefits from the ³/₄" resolution and the incredible detail of imagery. City of Savannah and Chatham County have committed to funding the Pictometry project. Ms. Hall noted that SAGIS worked with Pictometry to achieve a 40% discount on the purchase price.

C. Census 2020 – Lara Hall

i. Ms. Hall stated the LUCA response data was submitted last week and Census data deadlines are met. SAGIS will be assisting with the Census community education and outreach campaign.

D. Public Safety and E911 GIS - Lara Hall

i. Ms. Hall is co-chair as of July 2018, with David Anderson under Suzanne Cooler. She reviewed the Board and the process. An ordinance has to be written and adopted by all communities. The goal is to not duplicate street names in Chatham County. Working to make all data standards interchangeable; making all tables compatible. Determining how it impacts all partners and users.

Ms. Hall stated SAGIS is continuing to work with Chatham County engineering office on transitioning street centerlines and addressing to the County Engineering office. SAGIS is presently still maintaining both datasets and will be maintaining



each until a plan is in place to transfer responsibility. Ms. Hall stated Addressing standards for hydrants are being developed.

ii. The E911 Coordinator position responsibility has been incorporated into the Chatham County engineering department work program.

E. SAGIS Presentation - Lara Hall and Kevin MacLeod

i. Mr. MacLeod presented new features and analysis capabilities being added to the next-generation SAGIS.org Property Map Viewer, which will be released at the end of October. The new property value charting tools, Google Earth tool, Property Printout, Location Planning, and Advanced tools for site selection, were demoed.

• Jim Collins stated the new capabilities are excellent and very helpful for many uses for the community. He inquired about searching property sales by date range. Kevin MacLeod stated this was possible and demonstrated an example, as well as querying by several other attributes such as by zoning, property value, parcel size, and other parcel attributes.

• Holmes Bell inquired if there are training videos. Mr. MacLeod showed how to access the training videos. Holmes Bell suggested making the link more apparent and Mr. MacLeod acknowledged this was a good suggestion.
