Applications must be complete before the Board or Staff can begin the review process. Submit this application form, all supplemental documentation as required in the "Instructions: Submittal Criteria Checklist," and a filing fee check with one hard copy and in PDF electronic format. Each building is considered an individual project (with the exception of duplexes, identical rowhouses and accessory structures); therefore, submit a separate application and filing fee check for each building.

Public Notice for Historic District Board of Review Meetings:

The applicant is responsible for posting the Board Meeting signs provided by the MPC a minimum fifteen (15) days in advance of the meeting. Refer to Section 8-3030, Subsection (h) Public Notice of the Historic District Ordinance for additional posting requirements.
