I. Call to Order and Welcome

1. Order and Welcome

Mr. Karatassos called the meeting to order at 4:00 p.m. and welcomed everyone in attendance. He outlined the role of the Historic Site and Monument Commission.

2. Plaque Presentation to Walt Harper

Mr. Karatassos, on behalf of the Historic Site and Monument Commission and staff, presented a plaque to Mr. Walt Harper for the many years of dedicated service he rendered to the Review Board from 2008 to 2016. Mr. Harper served on the Commission due to serving as chair of the Park & Tree Commission.

Mr. Harper thanked the Commission for the plaque and said it was a pleasure serving on the Commission. Some requests they were able to do and some they were not able to do, but the Commission has to abide by the rules and regulations.

Mr. Karatassos informed the Commission that when the legislation created the Park & Tree Commission, a five member board was created. At some point later, City Council voted to have the Park & Tree Commission serve as a member of the Historic Site and Monument Commission. Since that time they have had a six member Commission. Mr. Karatassos said he spoke with the Clerk of Council and the City Manager regarding the possibility of trying to go back to being a five-member Commission, including the member of the Park & Tree Commission. If this is approved, they will have a five-member commission instead of having six members. He explained that this Commission needs to be a five-member commission or a seven-member commission.

Ms. Mary Reynolds and Mr. Quito Anderson were present on behalf of the petition.

Ms. Sara Farr gave the staff report. The applicant is requesting approval for two light projections on Broughton Street at 2 East Broughton Street and 2 West Broughton Street. They will be titled "Holidays on Broughton" and will run every Friday and Saturday from

November 25, 2016 to December 24, 2016 from 6:00 p.m to 9:30 p.m. A PA speaker system will also be used to play a variety of holiday music. The entire white portion of both facades of 2 East Broughton Street (Levy's) will be used for the projection. The projector for this location will be placed on 1 West Broughton Street (Panera Bread). The second projection will be on portions of the Sun Trust building along Bull Street. The projector for this installation will be on top of Levy's.

Ms. Farr stated that the projections will feature a variety of holiday themed images, including historic images of Savannah. Historic architecture that reflects the past of Broughton Street will be included. Examples of images include the logo for the Holidays on Broughton event, historic signs, and holiday themed graphics. Examples of the proposed projections were provided by the applicant. Music will also be incorporated and will meet all City ordinances. Public notices were sent to neighborhood groups and property owners located within 200 feet of the project.

Mr. Karatassos asked staff who was sponsoring this event?

Ms. Farr answered that she believes the event is being sponsored by the Broughton Street Development group, but there is no advertisement.

PETITIONER COMMENTS

Mr. Anderson of Ben Carter Enterprises stated that no advertising will be done. They are making this an inclusive area of the entire street. They will have historic architecture of the 1920s, 1930s and 1940s. They will also have images of the logo for the Holidays on Broughton event, historic signs, and holiday themed graphics. They will have colorful lights.

Ms. Reynolds explained that they will have a 40 foot artificial Christmas tree that will be located on Bull Street between the SunTrust Bank building and the Levy's building. The lighting of the tree will be on Friday, November 25, 2016 at 7:00 p.m. The various singing groups will perform around the tree. The tree will remain in place until January 2, 2017.

COMMISSION DISCUSSION

The Commission wanted to be certain that the merchants of Broughton Street were included in this event. The petitioner assured the Commission that this was an all inclusive event of the entire Broughton Street.
