  - Ms. Elyse Butler was present on behalf of the Georgia Historical Society.
  - **Ms. Sara Farr-Newman** gave the staff report. The petitioner is requesting approval for a marker near the intersection of 45th Street and Atlantic Avenue in Atlantic Mall. The marker will be freestanding and will commemorate Mayor Malcom Maclean. The marker was continued at the June meeting to allow the Neighborhood Association to meet with the petitioner regarding the original proposed site, Guckenheimer Park.

Ms. Farr-Newman reported that the marker will read as follows:

Malcom R. Maclean (1919-2001)

Malcom R. Maclean served in the U.S. Navy during World War II and the Korean War, rising to the rank of commander. After Harvard Law, Maclean entered Savannah politics. His fellow aldermen selected Maclean as mayor in 1960 to fill an unexpired term. Elected with bi-racial support in 1962, Maclean sought to avoid the violence surrounding the Civil Rights movement that occurred elsewhere and responded with moderation to protests and a boycott of segregated businesses. Maclean negotiated with business and civil rights leaders, including W.W. Law and Eugene Gadsen, to accomplish the largely peaceful desegregation of Savannah before the Civil Rights Act of 1964. Voters rejected Maclean's reelection bid in 1966. Maclean also helped establish Memorial Health hospital and recruit Gulfstream Aerospace. Maclean lived nearby on E. 45th Street and is buried in Bonaventure Cemetery.

#### **PETITIONER COMMENTS**

**Ms. Butler** said they met with the MPC staff, Traffic Engineer, and Park & Tree as well as the Chatham Crescent Ardsley Park Neighborhood Association. They looked at the location for the historical marker. She said they addressed the HSMC's concerns about accessibility with a sidewalk. The Atlantic Mall is actually closer to Mayor Maclean's home. Therefore, it makes better sense to relocate the marker to a more successful location. The proximity is closer.

- **Dr. Henry** asked Ms. Butler that as he recalled, the neighborhood association had some concerns about the initial location.
- **Ms. Butler** explained that the neighborhood association was unhappy with the Guckenheimer location because it would have brought people into the interior of the neighborhood.
- Mr. Karatassos stated the neighborhood association was amenable to the marker being erected, but

they wanted to review the petition. This is why the petition was continued at the June, 2017 meeting.
