Mr. Scott Stanton was present on behalf of the petition.

Ms. Sara Farr-Newman gave the staff report. The petitioner is requesting approval for a mural at 611 Habersham Street. The mural was previously reviewed for an after-the-fact approval at the August 3, 2017 meeting (17-003005-PA), but was not approved. The applicant removed the mural and is requesting approval to reinstall it. The mural will be the same and was approved by the HDBR on July 12, 2017 (17-003004-COA). Staff recommends approval of the mural with the condition a time frame is provided for its display and removal, because otherwise it meets the standards in the Master Plan and Guidelines for Markers, Monuments, and Public Art.

The following neighbors appeared and voiced opposition to the mural, Larry Tippins, Philip Perrone, Mary Beth Winslow, Tim Coy, and B. Trotter. They do not believe the mural is compatible with their residential neighborhood.

4. Commissioner Items

The Commission discussed the difference between a mural and a poster. Ms. Harris showed the Commission the current definition for murals. Mr. Karatassos stated that evaluating the murals and the posters the same way is troublesome to him. Ms. Harris explained that the Commission might want to include in their evaluation process that a mural must be 1) integrated architecturally into whatever surface it is going to be painted on and 2) if it is intended to be temporary or utilizes materials that are not permanent, that there is a specific removal date with the decision.

Mr. Daniel Carey of the Historic Savannah Foundation (HSF) suggested that one of the criteria conditions would be the lag time between the murals. One mural could be put up and in another day, a new mural could go up. But, from an architecturally point of view, should there be a lag time between them in order to let the building have its moment? May be the surface needs to breathe.

Ms. Dorothea Coy said the current definition for murals do not say that the art needs to be directly applied to the building structure. If something is painted directly on a board it would still be an object.

The staff will look at other alternatives pertaining to the murals and posters.
