**Ms. Sara Farr-Newman** gave the staff report. The applicant is requesting approval for a monument at 27 Abercorn Street. The Savannah Town Committee of The National Society of the Colonial Dames of America is requesting to reinstall the previously existing marker honoring John Wesley in front of the Sturgis House, which was originally the third monument or marker the Dames installed in Savannah. The marker was originally installed in 1903 but was removed sometime in the past 10 years. The plaque was stolen prior to the granite's removal, though the date is unknown. The marker is proposed to be reinstalled with a new plaque in the same location. A specification for the new plaque design and material will be provided at a later date.

#### **PETTIONER COMMENTS**

**Ms. Lora Martin** explained that the plaque that was on the house was installed by the Colonial Dames in 1903. The Sturgis House and the John Wesley Hotel are on the same trust lot. They visited the Georgia Historical Society and upon reading a 1938 newspaper they saw that the plaque was still on the John Wesley Hotel. However, some time during 1938 and 2000 the plaque was moved and installed on a large granite block. The granite block was located between the median and the street. Some ten years later, the plaque was removed. The Colonial Dames had Mr. Charlie DePue store the plaque at his monument company. They are now ready to reinstall the plaque and granite back in its old location.

**Deacon Clifford King** was present on behalf of the petition.

**Ms. Sara Farr-Newman** gave the staff report. The applicant is requesting approval for an honorary street designation. The block of West 38th Street between Martin Luther King Jr. Blvd and Montgomery Street is proposed to be named Rev. and Mrs. Lexcie E. Aiken Way. They have been at the church for 49 years and have served the community, particularly Carver Village. They founded the Feed-A-Meal program that serves people weekly and has been going on for 30 years. This designation will honor their impending retirement. Several hundred persons signed a petition supporting this proposal.

### **PETITIONER COMMENTS**

**Deacon King** stated that Rev. Aiken has been his pastor more than 35 years. Rev. Aiken has been the pastor of St. Luke Missionary Baptist Church for 49 years. During this tenure, Rev. Aiken has been instrumental in the 38th Street park beautification [the park is adjacent to the St. Luke church]. He has spearheaded several projects trying to uplift the many people who visit the park on a daily basis. Not only has Pastor Aiken served the St. Luke church, but many surrounding areas of the church. Rev. Aiken worked at the Savannah Sugar Refinery for more than 30 yeas where he was also instrumental in spreading the Gospel. Deacon King thanked the HSMC for hearing the request to name the block between Montgomery and Martin Luther King Jr. Boulevard to Rev. and Mrs. Lexcie E. Aiken Way.

# **PUBLIC COMMENTS**

**Ms. Evon Wright**, a member of the church, stated that Pastor Aiken was the first Black shipping clerk at the Sugar Refinery. St. Luke Baptist Church is a 106 years old and Pastor Aiken has been the pastor for 49 years. Therefore, the church wanted to honor Rev. & Mrs. Aiken for their many years of dedicated services to the church, the community, and the City of Savannah.

**Ms.** Alizina McCoy, a member of the church, introduced Rev.and Mrs. Aiken.

Many church members and citizens were present at today's meeting supporting this petition. Alderman Bill Durrence was present and supports the petition.

#### **Motion**

The Savannah - Chatham County Historic Site and Monument Commission does hereby recommend to City Council approval for the honorary designation of the block of West 38th Street bounded by Martin Luther King Jr. Blvd and Montgomery Street as Rev. and Mrs. Lexcie E. Aiken Way with the following conditions:

- 1. The road is not under the control of the Federal Highway Administration, GA Department of Transportation, or Chatham County;
- 2. The street sign is installed within 45 days of City Council approval;

  - **Ms. Sara Farr-Newman** gave the staff report. The applicant is requesting approval for a marker at 102 East Liberty Street. The marker is proposed to be bronze and located adjacent to the entrance of Drayton Tower on the building.
  - **Ms. Farr-Newman** reported that staff recommends approval for a marker at 102 East Liberty Street with the condition the text size is provided for staff approval, because otherwise it meets the standards.

#### **PETITIONER COMMENTS**

**Ms. Wierenga** said the building was started in 1949 and was completed in 1951. The building was designated in 1966. She believed that they needed to show the building's designated date. They have been trying for four years to get a plaque on this building. The plaque will be placed on a 11" x 8" bronze column. However, it can be wider if they need to do so.

**Ms. Harris** explained that the building was listed in 2013 on the National Register of Historic Places and was completed in 1951. The historic name of the building is "Drayton Arms Apartment."

# **HSMC DISCUSSION:**

The Board was unclear on why 1966 was on the plaque when the building was constructed in 1949-1951. The Board also wants additional information about the significance of the building incorporated.

#### **Motion**

The Savannah - Chatham County historic Site and Monument Commission does hereby approve a marker at 102 East Liberty Street with the following conditions to be provided for staff approval:

- 1. The text size is provided;
- 2. The years are corrected;
- 3. Additional context is provided on the plaque for the years and reason for the National Register Lsting;
