  - Ms. Erin Wessling was present on behalf of the petition.
  - **Mr. Ryan Jarles** gave the staff report. The applicant is requesting approval for a temporary mural to be installed on the front façade of 12 West State Street. The proposal is for a patterned stencil to be spray painted over the entirety of the front façade. The pattern was chosen due to its historical design. The mural is proposed to be in place for 30 days and then the façade will be painted back to its original color. Staff recommends that the scale be reduced significantly.
  - **Mr. Jarles** stated that as required in the Master Plan and Guidelines, written notice was sent to all property owners and the neighborhood association within 200 feet of the subject property. No comments were received.
  - **Mr. Jarles** reported that staff recommends approval for a temporary mural to be installed at 12 West State Street with the following conditions because otherwise the temporary mural meets the Historic Site and Monument Commission Master Plan and Guidelines:
    - 1. Reduce the scale of the mural significantly;
    - 2. Provide staff with funding source.
  - Mr. Monroe asked staff why did they recommend that the scale be reduced.
  - **Mr. Jarles** answered that the Historic Sites & Monument Commission's guidelines state that whatever is painted that it not distract from the character defining features, He explained that since the mural will be painted on the front of the building facing the street, the scale of the design needs to be reduced.
  - Mr. Mannion asked why the mural is requested to be up for only 30 days.
  - **Mr. Jarles** stated that this is a question that the petitioner will be able to answer when making her presentation to the Commission. But this request was for a temporary 30-day mural.

## **PETITIONER COMMENTS**

- **Ms. Wessling** came forward and gave the background data on the artist, Ms. Vanessa Platacis. Ms. Platacis has produced numerous works of art within the public area. Ms. Wessling stated that she talked with the owner of 12 West State Street and he approved for the mural to be painted on his building. The financing is funded by W Projects LLC. She entertained questions from the Commission.
- **Ms. Blakely** stated that the project is beautiful and she likes it. She asked, however, if the project would interfere with the historic designation, etc.
- **Ms. Wessling** answered that because the stucco is already painted it will not damage any historical materials if painted. The artist will use spray paint. The building will be returned to its original color 30 days after the

mural is painted. This is a temporary mural.

#### **COMMISSION DISCUSSION**

The consensus of the discussion was that the members of the Commission fully supported a reduced scale design that the petitioner presented to the Commission at the meeting. Commission member Lisa D. Watson expressed concern about the material proposed for use in creating the mural (spray paint), and expressed her desire for the artist to consider the utilization of a more environmentally friendly alternative to spray paint; the other members of the Commission shared the concern, but felt it was not within their purview to tell the artist which medium was appropriate for this specific piece of art. However, because of public safety, they were hopeful that the artist would consider choosing a different paint.

#### **Motion**

The Savannah - Chatham County Historic Site and Monument Commission does hereby approve a temporary mural, utilizing the reduced design, to be installed at 12 West State Street for 30 days with the additional recommendation that the artist consider taking public safety into account and consider choosing a different paint, because otherwise the temporary mural meets the Historic Site and Monument Commission Master Plan and Guidelines.

Chatham county - Savannah is fortunate to have over 8,000 documented historic and cultural resources and over 20 National Register Historic Districts. The resources provide a necessary contribution to the Character of our historic districts and neighborhoods.
