Ms. Leah Michalak presented the applicant's request for approval to name a portion of Bouhan Avenue (Between Waters Avenue and Reid Court) to Lt. White Avenue. Per the applicant: "Mr. White is the last living person of 'color' officer who was selected to 'Protect & Serve' in a time in our historic when it was not the best of time. He served his community with a standard that has not been surpassed; he is and was respected by the law enforcement community all over this state".

Lt. White is the last living member of "The Original Nine". All of the standards are met, and there are no restrictions.

As required in the Master Plan and Guidelines, written notice was sent to all property owners, and the neighborhood association, within 200 feet of the subject property. A sign was posted on the property fifteen days prior to the meeting. Staff received a letter of support from Alderwoman Linda Wilder-Bryan. No public comments were received.

Assistant City Manager Joe Shearouse, Alderwoman Linda Wilder, Alderman Nick Palumbo stated their support. Various family members provided memories and additional facts regarding Lt. White's service.

Ms. Wilson expressed her appreciation of Lt. White's service.

Ms. Baker expressed her experience of meeting Lt. White during a documentary process.

Mr. Monroe expressed his support of the project and hopes the documentary comes to fruition.
