Ms. Caitlin Chamberlain presented the staff report. The applicant is requesting approval for an installation of a mural on the property located at 1305 Barnard Street. The mural is proposed to be located on the façade that faces Henry Street and will cover a non-historic painted sign. It will be the full size of the wall and painted with high-quality exterior paints. The proposed theme represents Savannah's diversity and love of the city.

Per the applicant, "The Mailbox Café Community Mural is an art piece incorporating the love for our City's culture and diverse population." The original design has been modified from the first submittal which would have qualified as a sign rather than a mural because it included the business name. But the design has since been modified as originally shown in the submittal packet and staff found that the mural still could stand on its

own.

1305 Barnard Street was built in 1965, is a non-contributing resource, and currently functions as a mailbox café. The artist is Zay Hutchins a local artist and Savannah State University alumnus. With regard to materials, the artists will use Behr ultra stain blocking paint and primer and vandal guard anti-graffiti coating.

Staff recommends approval of the mural at 1305 Barnard Street as requested because the public art project meets the standards in the Master Plan and Guidelines for Markers, Monuments, and Public Art.

PETITIONER COMMENTS:

Mr. Kewan Drayton stated he wants to bring a vibrance to the area with the mural. A lot of their customers are SCAD students that come to the area to buy drinks and ship their packages. He stated that a lot of the students mentioned that the side of the building would be a great place for a mural. He mentioned that they also offer luggage storage and thought the mural would give tourists a good photo opportunity. This mural would bring attention to the business as well as color up the City.

Ms. Caitlin Chamberlain presented the staff report. The Applicant is requesting approval of a monument application, Part I: Theme, Location, and Preliminary Design, for the creation and installation of a five foot eight inches tall bronze bust of Reverend Andrew Bryan in Yamacraw Square.

Per the applicant, "the proposed bronze bust, rendered from approximately mid-chest up and positioned upon

a pedestal, is to be located on the east side within Yamacraw Square, facing west into the plaza towards an array of narrative bronze plaques. Yamacraw Square lies directly in front of First Bryan Baptist Church."

The Applicant provided a digital mockup of where the bust would be facing. There is no other such monument commemorating Reverend Andrew Bryan. The historic first Bryan Baptist Church is an African American church organized 12 years after the signing of the Declaration of Independence by Reverend Andrew Bryan formerly enslaved in 1788. Considered to be the mother church of Black Baptists, the site was purchased in 1793 and to date is one of the oldest continuous parcels of real estate owned by African Americans in the United States.

Staff recommends that the Historic Site and Monument Commission recommend approval to City Council for the application of Part I: Theme, Location, and Preliminary Design for the creation of a bronze bust of Reverend Andrew Bryan, to be installed in Yamacraw Square, as requested because the project meets the standards in the Master Plan and Guidelines for Markers, Monuments and Public Art.

Mr. Sean Mannion asked if the cost was a part of this phase.

Ms. Chamberlain stated the Applicant did provide a cost breakdown in the application, but it's not required for this phase.

PETITIONER COMMENTS:

Ms. Ellie Isaacs, Preservation Consultant for Petitioner stated that based on the pads and the plaques that are already in the square it would make more sense for the bust to face the way it is. She also indicated that there is the possibility of another bust being added in the future.

PUBLIC COMMENTS:

Mr. Ryan Jarles spoke on behalf of the Historic Savannah Foundation expressing their support of the bust.

Ms. Georgia Benton stated that she is the historian for the First Black Baptist Church and a part of the Yamacraw Restoration. She went on to say that this was a divine idea and looks forward to the addition of future busts.
