2. Petition of Georgia Historical Society, Elyse Butler | 22-006000-HM | Dixon Park at Intersection of East Broad Street and East Henry Street | Historical Marker

**Ms. Caitlin Chamberlain** presented the applicant's request for a recommendation of approval from the Historic Site and Monument Commission to City Council to install a 42"x 38" cast aluminum double-sided roadside historical marker in Dixon Park at the public right-of-way intersection of East Broad Street and East Henry Street to commemorate suffragist and community leader, Mamie George Williams.

As per the applicant:

"The historical marker highlights her political and social impact on a local, statewide and national level. The proposed location for the historical marker is in Dixon Park, the neighborhood where Mamie George Williams lived and worked."

The proposed marker is to read as follows:

Mamie George Williams, a life-long resident of Savannah, lived and worked near here. A political and civic leader, Williams volunteered for many organizations, including the Red Cross, the Girl Scouts, and the National Association of Colored Women's Clubs. A suffragist, she organized voter campaigns and registered African American women to vote following passage of the 19th Amendment. Nonetheless, African Americans were denied full voting rights, due to Jim Crow laws. In 1924, Williams became the first woman from Georgia and the first African American woman in the nation to serve on the Republican National Committee. A community leader, she led fundraising efforts for a home in Macon for African American girls and served as vice president of Carver State Bank. She worked with the African American Girl Scouts, financially assisting with establishing their Log Cabin Camp in Hancock County.

**Ms. Watson** asked if her living (residential) location can say Dixon Park. **Ms. Butler** stated that she did not live exactly there.

**Mr. Roger Raines**, area resident, concerned with trash usage instead of using the lane. Trash problem where the marker is proposed to be.

**Mr. Monroe** stated that it is out of purview.

**Ms. Victoria Jones** expressed concern about blight.

**Ms. Butler** stated there was discussion about moving the trash can; has considered moving marker to other side of the sidewalk.

# **COMISSION COMMENTS:**

The Commission expressed support of the marker and provided contact information for the residents regarding their trash and blight concerns.

The Historic Site and Monument Commission recommend approval to the Savannah City Council to install a historical marker in Dixon Park near the intersection of East Henry Street and Java Lane with the following condition because the proposed work otherwise meets the Master Plan and Guidelines:
