Ms. Caitlin Chamberlain presented the petitioner's request of approval for a sculptural letter installation at City Market, at approximately 232 West St. Julian Street and Jefferson Street.

Per the applicant:

"The proposed SAV sculptural letter project is an ambitious endeavor that is set to become an iconic symbol in Savannah. Comprising the letters "SAV," the acronym stands not only for the widely recognized and beloved hashtag for Savannah but also represents the Savannah airport code. Crafted from aluminum or similar metal material, the letters will exude a sleek and modern appeal capturing the essence of the city."

The overall height of the letters is 4'9" and the overall width of the sculpture is 13'8" which will be set atop an aluminum mounting plate and bolted into the concrete.

PETITIONER COMMENTS:

Mr. Joe Marinelli, petitioner, stated the intent is provide photo ops for those utilizing the convention center and City Market. The City Market location was deemed to be the best location for the signage. The background would capture the beauty and essence of City Market. It is not intrusive with pedestrian traffic flow. He stated the project will go to City Council.

Ms. Baker asked about the design process. **Mr.** Marinelli stated it is the airport signature code and the font is used often in 'Savannah' advertising.

Ms. Kostilnik asked who will clean graffiti and underneath. **Mr. Marinelli** stated there is an agreement with City Market: the tourism agency will pay for and gift to convention center and City Market. It is made of somewhat indestructible material. The cleaning will be the responsibility of the Convention Center and City Market. It is in writing between the tourism agency and City Market.

Mr. Mannion expressed concern about it being destroyed and why this location with all of the foot traffic and high probability of damage/vandalism. Mr. Marinelli stated the vibrancy of City Market, and the foot traffic is the very reason for the location selection. Ms. Watson liked the sample maintenance schedule provided. She stated the back view is odd; can something be put there. Mr. Marinelli stated that was considered and thought that would encourage attention to it and result in taking pictures.

Ms. Kostilnik asked about liability when parents put their children or unattended children on the letters. **Mr. Marinelli** stated he had no answer for that - can happen on anything downtown.

Ms. Kimberly Phillips, City Market, expressed excitement about the project. There will be fulltime maintenance staff to make sure it remains clean.

PUBLIC COMMENTS:

4:00 p.m.

Mr. Andrew Jones, Oglethorpe Plan, requests denial because it is not in harmony with Oglethorpe Plan. It obstructs the street; it is not a courtyard. Streets are mentioned in historic status letter from NPS. He stated inappropriate materials are proposed.

Ms. Ardis Wood, citizen, stated the location does not support the Oglethorpe plan or the viewshed sightlines. Requested denial.

Mr. Steve Edwards, Downtown Neighborhood Association expressed that the money spent on this can be better spent on other programs. This project is not necessary or appropriate.

COMMISSION COMMENTS:

Mr. Henry stated City legal representation should be had. Many issues brought up. **Mr. Monroe** stated he was not aware the property is the City's. **Mr. Mannion** states he likes it but thinks it will be an impediment of traffic.
