Ms. Caitlin Chamberlain presented the applicant's request of approval for a National Register of Historic Places sign for St. Philip AME Church, located at 613 Martin Luther King, Jr. Boulevard. The sign is already manufactured and was provided to the congregation by the William G. Pomeroy Foundation. The applicant seeks approval to be able to install the freestanding sign on the church property in an area that will be visible to pedestrians on Martin Luther King, Jr. Boulevard.

The marker text is as follows:

Saint Philip A.M.E. Church has been placed on the National Register of Historic Places in 1984 by the United States Department of the Interior William G. Pomeroy Foundation 2023

The sign was funded and manufactured through the William G. Pomeroy Foundation's National Register Signage Grant Program. The National Register of Historic Places Designation does not include funding for signage, so the Pomeroy Foundation seeks to fill that gap by providing grants for either a plaque or a marker for recognition of designated sites. At the time the sign was manufactured, the applicant was not yet aware of the process for installation and approval, hence the reason it already exists.

Staff recommends approval of the installation of the National Register of Historic Places sign on the property of St. Philip A.M.E. Church, 613 Martin Luther King, Jr. Boulevard with the following condition because otherwise the project meets the standards in the Master Plan and Guidelines for Markers, Monuments, and Public Art.

1. Ensure that there are no below ground utilities present at the proposed sign installation location.

- **Mr. George Lee, III**, pastor of St. John Baptist church, does not support petition, as there was no discussion with the church about this petition.
- **Ms. Vanessa Powers**, church member, feels it should be larger and included other pastors. Ms. Charlotte Perkins, another member of the church, agreed that prior pastors should be recognized as well.

COMMISSION COMMENTS:

Mr. Joe Shearouse stated an honorary street naming requires 51% support of adjacent property owners. The requirement has been met and encourages all to show as much support as possible.

Ms. Caitlin Chamberlain presented the applicant's request for approval of an honorary street designation on Hopkins Street, between West Victory Drive and West 48th Street, for an honorary name of "Coach Ronald Booker Way." This stretch of Hopkins Street is near Alfred Ely Beach High School, where Booker was an alumnus and also Head Coach of the "Lady Bulldogs" among other athletic accomplishments.

Staff recommends that the Historic Site and Monument Commission recommend <u>approval</u> to the Savannah City Council for an Honorary Street Designation at Hopkins Street between West Victory Drive and West 48th Street, in honor of Coach Ronald Booker <u>with the following condition</u> because the proposed honorary street designation otherwise meets the standards within *Article E- Naming and Renaming of Public Property, Facilities and Streets.*

1. Provide an endorsement letter from the Mayor or an Alderman.

Mr. Joe Sherouse stated the endorsement of elected officials is to monitor the number of street designations approved - two per year each. Additionally, the representative is to be aware so there is no dissent. Ms. Shabazz provided a letter stating her support.

Ms. Priscilla Swindell stated she felt Mr. Booker was worthy of the honor of the street designation.
