#### 5. 2010 Census Savannah Urbanized Area

Ms. Wykoda Wang gave a report on the 2010 census, that it will have an impact on the current MPO boundaries and funding. The new census would have Richmond Hill in Bryan County and a little of Effingham County included in our MPO boundary. The staff is still working on determining definite boundaries. The MPO is to include urbanized areas plus any area that is expected to be urbanized within the next twenty years. Once this is determined, changes in the MPO membership could be made and a Memorandum of Understanding with GDOT will be issued.

## 7. Presentation

Regarding Teleride service, Mr. William Law stated that on time performance is still up and ridership increased 5-10 %. No shows and cancellation are steadily declining. The Teleride guide book is almost ready to be shared with this group. From January to June CAT would like to have a trial of all the new guidelines before it goes live.

Regarding proposed changes to CAT's fixed routes, there will be town to town meetings so that the public can come and make comments.

They are working on implementing the ITS system.

Ms. Heagarty asked how will ACAT get the Teleride handbook so they can review it before it goes out to the public.

Mr. Law stated that he hopes it will be done by the next ACAT meeting in October so he can provide it then.

Ms. Wang recommended that there be a public comment period before the trial period starts.

Mr. Law stated that he would check into that.
