Ms. Jane Love stated that this is the MPO's long range plan. Revions to the draft report since its initial publication on July 25th consisted of responses to comments received from FHWA and updated prjoect information from project sponsors.

She reviewed the Transit part of the plan, which comes from CAT's Transportation Development Plan. It includes: quality of service improvements such as increasing service hours of operation and frequency of service; improving on-time performance; adding additional routes to improve east-west connectivity and travel options utilizing 37th St., Victory Dr., 59th St./Columbus Ave. and DeLesseps Ave.; adding zonal services utilizing smaller vehicles that connect to the fixed route service; implementing regional commuter express service from neighboring counties; and enhancing commuter services (carpools and ride-matching, employer vanpools).

Ms. Denise Boehner asked about audible pedestrian signals. She has heard people say they are needed on DeRenne Ave. and at Skidaway Rd./ Victory Dr. intersection. Ms. Love said those types of things might be included as projects get farther into design.

Staff recommended ACAT endorsement of the Total Mobility Plan.

6. Update on the Draft Non-motorized Transportation Plan

Ms. Jane Love stated that the Non-motorized Transportation Plan is a bicycle and pedestrian plan. It will replace the current Chatham County Bikeway Plan developed in 2000 and include pedestrian projects. She reviewed the steps already completed in the development process.

Ms. Love reviewed the project list and the ranking criteria. This plan looks at stand-alone projects that may be simpler to undertake than projects that are part of a larger thoroughfare project.

The next steps are to complete the draft plan, conduct public meetings and address public comments, and then request adoption of the plan at the October meeting.

# A. Teleride

7. Presentation

Ms. Kim Anderson gave the Teleride ridership July 2014 was 7,055 and July 2013 was 6,725. Staff met with a few of paratransit customers regarding the challenges and concerns they had with the service and call center. Staff is working to address all of the concerns that were expressed, one mainly being the notification process had an error message but that now is fixed. In July CAT offered a service for the 4th of July and that ridership was 918. On August 24, 2014 Teleride staff had a customer training class. With the call back system and automated call gives you the option to confirm or cancel your ride but you have to listen to the whole message to get the options. If the system leaves you a message and you want to cancel, then you have to call in or by default it will confirm your ride.

Fix route ridership in July 2014 was 291,783 compared to 288,148 in July 2013.

### **B.** Chatham Area Transit

  - Ms. Jessie Fernandez-Gatti reported the following:
    - Abercorn Express (14x) currently stops at Savannah Mall and GDOT's I-95/SR 204 Park and Ride lot, but they want to go no farther than Savannah Mall in future (given the existing ridership). CAT talking to Savannah Mall about a Park & Ride lot arrangement there.
    - Airport Express (100x) considering adding some Sunday service.
    - Fares on the express routes might be raised to \$3.00 \$5.00 (currently only \$1.50 like local routes).
