3. FY 2014-2017 Transportation Improvement Program (TIP) Amendment

Ms. Jane Love reminded the committee of the purpose of the Transportation Improvement Program (TIP), as the short-range programming document showing the area's federal funding for highway and transit projects. She said that the MPO received a request in January 2014 from Chatham Area Transit Authority (CAT) to amend the FY 2014-2017 TIP to add the Section 5309 Program to fiscal year 2014. The Section 5309 Program awards funding to eligible recipients based on a competitive selection process. CAT applied and was awarded \$2.5 million of Section 5309 federal funding and plans to use the money for bus related improvements. The awarded funds must be programmed in the TIP before CAT can access them.

She said staff recommends ACAT endorsement of the amendment to the FY 2014-2017 TIP.

4. Total Mobility Plan / 2040 Long Range Transportation Plan (LRTP) Status Report

Ms. Jane Love updated the committee on the status and process of the Total Mobility Plan/2040 LRTP. Plan development tasks that are currently underway are development of

the Project Prioritization Method, the Financial Plan, and Project Identification. The prioritization method consists of two screening steps, with the first based on need and the second based on sustainability. Projects will be compared on how they address the plan's goals, using measures based on readily available data.
