I. Approval of Agenda

Ms. Pamela Oglesby motioned to approve the October 28, 2019 CORE MPO ACAT meeting agenda; seconded by Mr. Stu Kluger. The motion was passed with none opposed.

Ms. Wykoda Wang motioned to approve the August 5, 2019 ACAT Meeting Minutes; seconded by Ms. Pamela Oglesby. The motion was passed with none opposed.

Ms. Pamela Oglesby motioned to approve the 2020 ACAT meeting calendar; seconded by Mr. Stu Kluger. The motion was passed with none opposed.

3.Safety Targets

Ms. Stephanie Rossi presented the CORE MPO 2020 Safety Targets. The Moving Ahead for Progress in the 21st Century Act (MAP-21) and Fixing America's Surface Transportation Act (FAST ACT) require that all state departments of transportation and metropolitan planning organizations use a performance-based planning and programming approach as part of the Transportation Performance Management (TPM) program. As part of the TPM, each state DOT and MPO must adopt targets to strive for within the planning and programming process. GDOT is required to set Safety Targets annually and has set their targets for 2020. CORE MPO has the option of supporting the State's Safety Targets or create its own unique targets. These targets must be adopted by February 27, 2020.

The Safety Targets are set on the performance measures listed below.

- 1. Number of Fatalities
- 2. Rate of Fatalities per 100 million Vehicle Miles Traveled (VMT)
- 3. Number of Serious Injuries
- 4. Rate of Serious Injuries per 100 million VMT
- 5. Number of Non-motorized Fatalities and Non-motorized Serious Injuries

The Safety Targets adopted by the State of Georgia for 2020 include the following.

- Number of Fatalities 1,698.0 To maintain the 5-year moving average traffic fatalities under the projected 1,698 (2016-2020) 5-year average by December 2020
- Number of Serious Injuries 24,094.0 To maintain the 5-year moving average serious traffic injuries under the projected 24,094 (2016-2020) 5-year average by December 2020
- Fatality Rate 1.280 To maintain the 5-year moving average traffic fatalities per 100 million vehicle miles traveled under the projected 1.28 (2016-2020) 5-year average by December 2020

- Serious Injury Rate 21.800 To reduce the 5-year moving average serious traffic injuries for every 100 million vehicle miles traveled under the projected 21.8 (2016- 2020) 5-year average by December 2020
- Total Number of Non-Motorized Fatalities and Serious Injuries 1,163.0 To maintain the 5-year moving average non-motorized fatalities and serious injuries under the projected 1,163 (2016-2020) 5-year average by December 2020

MPO Staff is recommending that the CORE MPO ACAT endorse supporting the State's Safety Targets through the MPO planning and programming activities.

Ms. Wykoda Wang motioned to endorse supporting the States adopted 2020 Safety <u>Targets</u>; seconded by Mr. Neil Ligon. The motion was passed with none opposed.

III. Status Reports

<u>4.Update of the Non-Motorized Transportation Plan</u> @ <u>Amendments to Non-motorized Plan Staff Report.pdf</u> @ <u>NMTP Update.pdf</u>

Ms. Stephanie Rossi gave an update on the Non-Motorized Transportation Plan. The plan was adopted in October 2014. Staff is conducting the update to consider new studies and plans that were started after the plan adoption such as Tide-to-Town, East Coast Greenway, and the Coastal Georgia Greenway. Staff wants to ensure that we are capturing what partner agencies have been doing over the last several years and illustrate this in the plan.

The CORE MPO's Long Range Transportation Plan, Mobility 2045, has been recently adopted. Mobility 2045 references the Non-motorized Transportation Plan in its Non-Motorized Set Aside Policy Statement for bike and pedestrian improvement projects. The Mobility 2045 policy statement states that for a bike/pedestrian/trail project to be eligible for funding, the project must be consistent with the Non-motorized Transportation plan. MPO staff intends to have the plan updated prior to the upcoming Call for Projects.

A non-motorized working group will be formed in November 2019. The group and MPO staff will review the proposed changes and modify the plan between the months of December 2019 and January 2020. Staff will bring the plan before the ACAT and CORE MPO Board for endorsement and adoption in February. This will allow the projects listed in the plan to be eligible for MPO funding.

Members interested in being apart of the working group are urged to sign-up with Ms. Rossi. Many of the changes to the plan include adding additional routes or removing redundant routes. The plan will also include the upgrading of facility types that offer more protection or comfort.

Mr. Aberson asked what's the difference between a bike lane and cycle track. A cycle track is separated by a barrier.

Ms. Pala Valdez asked if the plan will include sidewalks in addition to the bike lanes. Sidewalks and bike lanes are considered pedestrian areas. Ms. Rossi stated that what is implemented depends on the facility and recommendation. Mr. Aberson stated that the MPC website list the Proposed Amendments to Bikeways and Proposed Amendments to the Pedestrian Network.

LIFE

Mr. Neil Ligon stated that L.I.F.E. will be hosting an open house on November 14, 2019 at their new facility located at 4811 Waters Ave. The event starts at 10:00am and will last throughout the evening.

Chatham Area Transit

Ms. Brigittee Morrison stated that she has been hired as the new Paratransit ADA Manager. Ms. Ashley Wilson has been hired as the call center supervisor. CAT is partnering with other agencies to develop best practices for implementing their Travel Training Program. A soft launch is expected for the 1st quarter of 2020. That program will be spearheaded by Ms. Brigittee Morrison, Ms. Tia Baker, and Ms. Demetria Freeman.

Mr. Aberson inquired on the Paratransit vans. Ms. Morrison stated that the fleet is running and there hasn't been any major accidents or maintenance issues.

Ms. Wang inquired on the updates to the Transit Development Plan (TDP). This is a 5-year planning document for transit agencies outlining priorities. Ms. Rossi stated that this plan was not directly related to the route redesign.

Committee Discussion

Mr. Stu Kluger asked if the Mobility 2045 Long Range Plan addresses electric cars and potential filling/recharging stations. Ms. Rossi stated that the Mobility 2045 does not have that level of specificity, this information may be within City or local jurisdictions. The City of Savannah has installed charging stations around the City and in many of the City parking garages. Mr. Kluger was advised to speak with the City of Savanah Parking and Mobility department.

Ms. Wykoda Wang stated that every year GDOT has discretionary funds for planning studies. Currently, the MPO is conducting two studies, the I-16/Little Neck Road Interchange Study and I-95/Airways Ave. Interchange study. These studies are funded by the discretionary planning funds and will end in December. Local agencies interested in sponsoring a study are encouraged to reach out to MPO staff. Staff is preparing to issue a Call for Studies at the beginning of the UPWP development. After the Call for Studies, staff will facilitate applying for the discretionary funds. Discretionary PL funds pay for 80% of the study, while the local agency pays for the remaining 20%. Garden City and Chatham County have expressed interest in sponsoring a project.
