Ms. Jane Love reviewed the proposed FY 2015 - 2018 TIP amendments, the comments that had been received during the comment period, and staff's responses to the comments. MPO staff recommended MPO Board approval of the amendments as presented in the staff report that had been revised to reflect updated figures from CAT.

There was public hearing for the TIP amendment to the FY 2015-2018 TIP.

Mr. Tom Thomson read a opening statement before the public hearing was opened by the Chairman.

A few members of the public spoke about the Truman Linear Park Trail. They all had the same comments to keep the Trail in FY 2016 instead of moving it to FY 2017. One person expressed concern that splitting the project into two segments might negatively effect the quality of the final trail for users, especially since the dividing point is at DeRenne Avenue, where right-of-way constraints are challenging. Another person expressed concern about the inefficiency and cost increase related to splitting the project into two separate projects.

The Chairman closed the public hearing. During the board discussion, Ms. Stephanie Cutter said that the City has agreed to maintain the entire Truman Linear Park Trail after it is built. Mr. Lee Smith stated that he supports his staff's position for splitting of the project and programming for FY 2017.
