FEBRUARY 2020 CALL FOR PROJECTS

The Coastal Region Metropolitan Planning Organization (CORE MPO) is conducting a competitive project selection process to award expected FY 2022 - 2024 Surface Transportation Block Grant (STBG) Program Urban Attributable (Z230) funds, provided through the act entitled Fixing America's Surface Transportation Act (also known as FAST Act).

- Expected Available Funds:
 - FY 2022 = \$4,000,000 (federal portion)
 - o FY 2023 = \$4,000,000 (federal portion)
 - FY 2024 = \$4,000,000 (federal portion)
- Maximum Award Each Year = \$4,000,000 (federal portion)
- Minimum Award for a Project = \$200,000 (federal portion)
- At least 20% of the eligible costs of the proposed project must be locally funded.
 (Previously incurred costs cannot be counted as part of the 20% match for the newly awarded federal funds.)

An applicant may request a minimum of *at least \$200,000 of federal funds*. The federal funding request in this application can represent no more than 80% of the total cost of the applicant's proposal. For example, if an applicant requests \$1,000,000, and provides no more than the required 20% local match, he/she would be submitting a proposal totaling \$1,250,000.

Federal Requirements

Applicants should keep in mind that using the STBG funds involves adherence to federal requirements, as applicable, such as the National Environmental Policy Act (NEPA), prevailing wage rates (Davis-Bacon), Buy America, competitive bidding, and other contracting requirements, regardless of whether the projects are located within the right-of-way of a Federal-aid highway.

 Projects funded through this selection process must be located within the CORE MPO's Metropolitan Planning Area (MPA) boundary.

The CORE MPO - administered STBG Urban Attributable funds can only be spent within the MPO's Metropolitan Planning Area which includes all of Chatham County, the portion of Effingham County and Bryan County located within the Savannah Urbanized Area, as well as Richmond Hill.

Projects, if awarded funds, will be programmed in the CORE MPO's FY 2021 – 2024
 Transportation Improvement Program (July 1, 2020 – June 30, 2024).

Once the project is programmed in the TIP and the awarded federal funding is authorized in the program year, the funds must be obligated within two years, otherwise the funds will be rescinded for use by other selected priority projects.

Project is located in western Chatham between Interstate 16 and State Route	County and southeast Effingham County, 204 (Fort Argyle Road).

This proposed project will upgrade the existing, two-lane rural collector road with additional pavement thickness, safety and operational improvements including access control and intersection traffic control features. Growth trends in this area along with recent manufacturing and warehouse development and large, undeveloped tracts of land to be developed indicate the need to beginning planning improvements along this corridor. Commercial and industrial traffic are anticipated in the near future on Old River Road to support the Georgia Ports Authority and the growing economy in Chatham and Effingham Counties. The existing road was not designed for heavy truck traffic and will require new pavement structure as well as additional turn lanes and intersection improvements to safely accommodate the expected increase in the size and volume of vehicles. A traffic study will be done to specify where improvements are needed. Accomodations for non-motorized users will be considered and included as appropriate based on a study. Right of way will be purchased for a future four-lane, divided corridor when warranted by traffic volumes.

The requested Z230 funds will be used to help pay for preliminary engineering and right of way acquisition. In order to meet logical termini requirements of the FHWA, the limits of the project are multi-jurisdicitional. As such, close coordination of the project with GDOT will be required. Additional funding will be requested for future phases as the project develops, but it is imperative to begin PE for the project now. The Jimmy DeLoach Parkway, Phase 2 project began in 1996 and was not approved for construction until 20 years later. We must begin planning for this important improvement project now.

The proposed project will improve regional connectivity by facilitating more efficient flow of both local and commercial traffic on Old River Road between Interstate 16 and State Route 204 (Fort Argyle Road). The project will look to improve the operation and safety with a design that incorporates current federal standards and accommodates non-motorized transportation. Access control, turn lanes and intersection improvements will ensure an acceptable level of service and travel reliability on the corridor even with the increased commercial and industrial traffic expected. The project will support the Georgia Ports Authorities continued growth as well as economic development that is already occurring and will continue to occur along the corridor. By closely coordinating with Effingham County, this project can help support the continued expansion of our regional economies, meet logical termini for the project as required by FHWA and provide access to new jobs.

The project is anticipated to have minimal impacts on the environment and will likely require no residential or commercial displacements. However, as development continues to occur along the corridor, it is imperative to begin Preliminary Engineering for the project to help avoid displacees in the future. This project will be a primary candidate to receive a future BUILD grant to help fund construction through the FHWA, as these grants target rural areas and projects. However, these grants also give priority to projects that are shovel ready. As it can take multiple years to develop a project through GDOT and FHWA, it is imperative to begin planning and preliminary design for the project immediately.

Dear Ms. Wang:


Effingham County supports and will work with Chatham County and the Georgia Department of Transportation to look for opportunities to improve Old River Road from Interstate 16 to State Route 204 (Fort Argyle Road). I will work with my Board of Commissioners over the next year to identify funding opportunities for the local match to support development of Preliminary Engineering for the project. This match will only be required if Z230 funds are awarded in FY2022 or a later fiscal year.

In addition, if a traffic study or our qualitative analysis of the safety of the intersection, truck traffic, and Effingham County Industrial Development site traffic shows the need to expand the logical termini of the project beyond Interstate 16 to Highway 80, I would like this to be considered during preliminary development of the project.


