The Coastal Region Metropolitan Planning Organization (CORE MPO) is conducting a competitive project selection process to award expected FY 2026 - 2030 Surface Transportation Block Grant (STBG) Program Urban Attributable (Y230) funds, provided through the act entitled Infrastructure Investment and Jobs Act (IIJA, Pub. L. 117-58).

- Expected Available Funds (subject to change):
 - FY 2026 = \$19,000,000 (federal portion)
 - FY 2027 = \$4,000,000 (federal portion)
 - FY 2028 = \$4,000,000 (federal portion)
 - o FY 2029 = \$4,000,000 (federal portion)
 - FY 2030 = \$4,000,000 (federal portion)
- Maximum Award for a project = available funds for that year (federal portion)
- Minimum Award for a Project = \$200,000 (federal portion)
- At least 20% of the eligible costs of the proposed project must be locally funded.

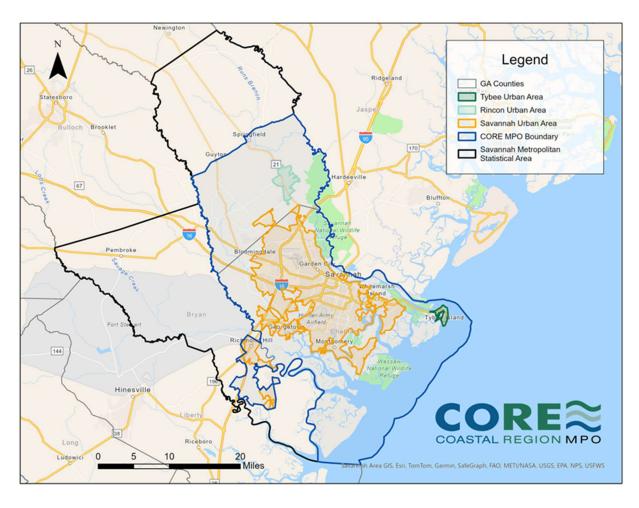
An applicant may request a minimum of *at least \$200,000 of federal funds.* The federal funding request in this application can represent no more than 80% of the total cost of the applicant's proposal. For example, if an applicant requests \$1,000,000, and provides no more than the required 20% local match, he/she would be submitting a proposal totaling \$1,250,000.

• Federal Requirements

Applicants should keep in mind that using the STBG funds involves adherence to federal requirements, as applicable, such as the National Environmental Policy Act (NEPA), prevailing wage rates (Davis-Bacon), Buy America, competitive bidding, and other contracting requirements, regardless of whether the projects are located within the right-of-way of a Federal-aid highway.

 Projects funded through this selection process must be located within the CORE MPO's Metropolitan Planning Area (MPA) boundary.

The CORE MPO - administered STBG Urban Attributable funds can only be spent within the MPO's Metropolitan Planning Area which includes all of Chatham County and portions of Effingham County and Bryan County (see map on the next page).

Projects, if awarded funds in FY 2026 and FY 2027, will be programmed in the CORE MPO's FY 2024 – 2027 Transportation Improvement Program. Awarded projects in FY 2027 will be carried over to the FY 2027 – 2030 TIP as well. FY 2028 – 2030 funds will build the prioritized waiting list for projects to be included in the FY 2027 – 2030 TIP (revisit the prioritization during TIP development).

Once the project is programmed in the TIP and the awarded federal funding is authorized in the program year, the funds must be obligated within two years, otherwise the funds will be rescinded for use by other selected priority projects.

Proposal Description Summary

This project includes the widening of Old River Road from two to four lanes from State Route 204 in Chatham County to I-16 in Effingham County (approximately 3 miles). This proposed project will upgrade the existing two lane rural collector road with additional pavement thickness, drainage, safety and operational improvements including access control and intersection traffic control features. Growth trends in this area along with recent development and plans indicate a need for improvements along this corridor. Commercial and industrial traffic are anticipated in the near future on Old River Road to support both the Port of Savannah and the growing economy in Chatham County. The existing road was not designed for heavy truck traffic and will require new pavement structure as well as additional turn lanes and intersection improvements to safely accommodate the expected increase in the size and volume of traffic. A traffic study will be done to specify where improvements are needed. Accommodations for non-motorized traffic will be considered and included as appropriate based on the study.

The Old River Road Widening Project proposes to expand Old River Road from two to four lanes between State Route (SR) 204 in Chatham County and Interstate 16 in Effingham County, a distance of approximately three miles. The project will upgrade the existing two-lane rural collector to a four-lane divided facility designed to accommodate industrial, commercial, and freight traffic. Planned improvements include increased pavement thickness, enhanced drainage, and operational upgrades such as access control, intersection improvements, and traffic control features. Accommodations for non-motorized users will be evaluated through the concept report.

Growth trends in western Chatham and southern Effingham Counties demonstrate a clear and immediate need for capacity improvements along this corridor. The Old River Road corridor serves as a critical link between SR 204 and I-16, both designated evacuation routes, and connects several existing and planned industrial developments, including the 744-acre Savannah Chatham Manufacturing Center, which currently has 12 developable sites available. Additional land along the corridor remains open for future industrial or commercial development, making this corridor strategically important for supporting regional economic growth and freight mobility. According to the National Hurricane Center storm surge mapping, this area may be vulnerable to storm surge during a Category 3 hurricane, emphasizing the need for a resilient transportation link between SR 204 and I-16 for evacuation and emergency response.

Traffic along Old River Road continues to increase, with an Average Annual Daily Traffic (AADT) of 5,790 vehicles per day and truck traffic representing 9.2 percent of total volumes. As development expands, this corridor will see higher freight demand generated by industrial users serving the Port of Savannah and surrounding logistics facilities. The existing roadway was not designed for heavy truck traffic and will require new pavement structure, added turn lanes, and upgraded intersections to safely accommodate the expected increase in the size and volume of vehicles. The Pavement Condition Survey within the Chatham County Congestion Management Process identifies the corridor as being in fair to poor condition, though portions have been overlaid with new asphalt as of July 2024.

Operationally, the corridor currently functions at Level of Service (LOS) C or better under the 2050 E+C Daily LOS model. Widening Old River Road will preserve this level of service and improve safety, reliability, and access for both local and regional users.

The project area is located within a high-poverty census tract, where access to reliable transportation options is limited. There are no transit routes serving this corridor, and the Dollar General located on the south end of the project serves as one of the few points of daily necessity for nearby residents. The lack of transit, combined with limited local destinations, underscores the importance of considering non-motorized accommodations for safe access to basic services. These potential multimodal improvements will be further evaluated during the concept development phase. The Old River Road Widening Project is consistent with the GDOT Coastal Empire Study, Chatham County SPLOST, and the Georgia Freight Plan Update. The project is included in SPLOST and identified within Cost Band One. Chatham County, as the local sponsor, is partnering with Effingham County to share the local match and fund all phases of project development.



Cost Estimate Justification

The Coastal Empire Study estimated the project cost at \$16 million in 2022 dollars. Escalating the estimate to a 2030 construction year using a 25% cost increase results in a total projected cost of \$20 million. An additional \$500,000 was included to account for right-of-way acquisition. The total project cost was then distributed based on cost trends from comparable projects, with 10% allocated to Preliminary Engineering, 15% to Right-of-Way, 10% to Utilities, and the remaining 65% to Construction.

Project Description

Capacity Adding Increased Connectivity Proximity to Industrial Development

This project includes the widening of Old River Road from two to four lanes from State Route 204 in Chatham County to I-16 in Effingham County (approximately 3 miles) and is recommended to be a locally led project.* The purpose of this project is to provide redundancy in the network by improving parallel routes to I-16.

Located near several planned industrial developments, the Old River Road widening project will provide improved access and capacity for freight traffic. Widening the corridor will also mitigate congestion associated with the planned developments.

This project is included in Coastal Region (CORE) MPO's Mobility 2045 Metropolitan Transportation Plan to address the need for the corridor to better accommodate freight traffic.

The project is anticipated to have a straightforward permitting process relative to other recommended projects.

The Old River Road widening project will provide improved access and capacity for freight traffic.

ISSUE:

Request Board approval to submit a Surface Transportation Block (Y230) Grant application to the Coastal Region Metropolitan Planning Organization (CORE MPO) for Old River Road Widening in the amount of \$20,500,000 for Preliminary Engineering, Right-of-Way, and Construction and execute required documents. (NOTE: Local match in the amount of \$4,100,000 will be required.) [Districts: 2 & 3.]

BACKGROUND:

The widening of Old River Road from two to four lanes between State Route 204 in Chatham County and I-16 in Effingham County (approximately 3 miles) was identified in GDOT's February 2023 Coastal Empire Study as a recommended locally led project. The project will provide redundancy in the regional transportation network by improving a parallel route to I-16. Located near several planned industrial developments, the Old River Road widening will improve access and capacity for freight traffic, mitigate congestion associated with new development, and enhance connectivity for the region. This project is also included in the CORE MPO's Mobility 2050 Metropolitan Transportation Plan to address freight accommodation needs.

FACTS AND FINDINGS:

- 1. Staff is applying for funding for preliminary engineering, right-of-way, and construction.
- 2. The Coastal Empire Study cost estimates are in 2022 dollars. Staff has increased the cost estimate to account for the rising cost of construction.
- 3. Staff has prepared a Y230 Grant application for \$20,500,000 for submittal to the CORE MPO. If awarded, these funds will require a local match of \$4,100,000. Staff is coordinating a cost share with Effingham County for 50% of the local match. Funding applications are due on October 10, 2025.

BLUEPRINT ALIGNMENT:

1.4.2.4. Goal 4: Provide effective and efficient government services while ensuring that processes and procedures are planned and executed with transparency.

FUNDING:

Should the grant be awarded, local match funds are available in SPLOST. This project has been included in the SPLOST VIII project list.

ALTERNATIVES:

1. Board approve to submit a Surface Transportation Block Grant(Y230) Grant application for Old River Road Widening to the CORE MPO in the amount of \$20,500,000 for

preliminary engineering, right-of-way and construction; and have the Chairman execute the documents required for application.

2. Do not approve the grant application.

The Effingham County Board of Commissioners is pleased to submit this request for STBG Y230 funding for the Old River Road Widening Project (SR 204 to I-16).

Effingham County hereby confirms that TSPLOST and SPLOST funds are available to provide the required half of the 20% local match in the amount of \$2,050,000 for the total project cost of \$20,500,000. Chatham County will provide the remaining half of the 20% local match required in the amount of \$2,050,00 to fund the project. Effingham County respectfully requests federal STBG Y230 funding of \$16,400,000 (80%) to complete this project.
