Resolution to Update the FY 2018 – 2021 Transportation Improvement Program of the Coastal Region Metropolitan Planning Organization (CORE MPO)

WHEREAS, the Coastal Region Metropolitan Planning Organization (CORE MPO) has been designated by the Governor of Georgia as the Metropolitan Planning Organization of the Savannah urbanized area in accordance with federal requirements of Title 23, Section 134 of the United States Code to have a cooperative, comprehensive and continuing transportation planning process; and

WHEREAS, CORE MPO adopted the FY 2021 – 2024 Transportation Improvement Program (TIP) on December 9, 2020; and

WHEREAS, the FY 2021 – 2024 TIP will not become official until the Governor of Georgia signs off on the Statewide TIP (STIP) which references the CORE MPO's TIP; and

WHEREAS, the current CORE MPO FY 2018 – 2021 TIP is still the programming document for fiscal year 2021 until the STIP is signed by the Governor; and

WHEREAS, CORE MPO desires to adopt updates to the FY 2018 - 2021 TIP for the CORE MPO Metropolitan Planning Area for fiscal year 2021 to reflect the updated information contained in the FY 2021 - 2024 TIP and the latest developments; and

WHEREAS, the proposed TIP updates include revisions to revenues, project schedules and cost estimate changes for both highway and transit programs as outlined in the TIP update staff report; and

WHEREAS, CORE MPO has completed the public review and comment period for the proposed TIP updates according to the Participation Plan and addressed all comments received; and

WHEREAS, CORE MPO has conducted a virtual public hearing for the proposed updates, and has taken into consideration comments made at the public hearing; and

WHEREAS, all requirements of the Participation Plan pertaining to TIP amendments and administrative modifications have been met.

NOW, THEREFORE, BE IT RESOLVED THAT, the Coastal Region Metropolitan Planning Organization approves the proposed updates to the FY 2018 - 2021 Transportation Improvement Program as shown in the summary of TIP update staff report with any corrections based upon the motion of February 24, 2021.

Updates to the FY 2018 – 2021 Transportation Improvement Program of the Coastal Region Metropolitan Planning Organization (CORE MPO)

February 2021

The Transportation Improvement Program (TIP) is the MPO's short-range programming document and is a staged, multi-year listing of surface transportation projects proposed for federal, state and local funding within the metropolitan area. The TIP may be modified in accordance with the procedures outlined in the adopted Participation Plan by resolution of the CORE MPO Board if priorities, area goals, project schedules or funding levels change. The CORE MPO's FY 2018 - 2021 TIP was adopted by the MPO Board in June 2017. Various administrative modifications and TIP amendments have been processed for projects over the past three years. The original adopted TIP and the amendment reports are all available for review on the MPO website at https://www.thempc.org/Core/Tip2040.

In December 2020 the CORE MPO Board adopted the FY 2021 – 2024 TIP. This new TIP will not become official until the Governor of Georgia signs off on the Statewide TIP (STIP) which references the MPO's TIP. As of February 2021, the FY 2018 – 2021 TIP is still the guiding programming document for FY 2021. It is important to make sure that the information contained in this document for FY 2021 is current and reflective of the most up-to-date revenue projections, cost estimates and development schedules as outlined in the FY 2021 – 2024 TIP. It is also important to ensure that the FY 2021 programming information is reflective of recent developments since FY 2021 – 2024 TIP adoption.

The timing is important for these projects/phases programmed in FY 2021 as this fiscal year ends on June 30, 2021. If a new project/phase is being programmed in this year or a project/phase has an updated cost estimate or schedule, administrative modifications or TIP amendments are needed to reflect the current project development status.

The following summary outlines the changes to FY 2021 in the FY 2018 – 2021 TIP.

Revenue Updates

The revenues for FY 2021 are different between the two TIPs. These changes impact the proposed amendments and administrative modifications. The table below lists the revenue updates for three highway programs. The transit revenue updates are included in the proposed changes below.

2. TRUMAN LINEAR PARK TRAIL - PHASE II-B

- **Project description:** The Truman Linear Park Trail is the demonstration project for initial implementation under the Coastal Georgia Greenway Master Plan. Phase I trail construction is completed. Phase II is proposed as a development of a multiuse trail from Phase I at 52nd Street and Bee Road to Lake Mayer Community Park. Phase II-B will complete the multiuse trail from

DeRenne Avenue to 52nd Street/Bee Road, to be implemented by the City of Savannah. This is an ADA compliant trail.

7. I-16 @ SR 17

• PI #: 0017515

- MTP Priority: PE, ROW and CST phases are included in Cost Band One of 2045 MTP.
- **Project description:** The proposed project will improve the existing interchange to safely and efficiently mitigate the expected future traffic increase from the Jimmy Deloach Parkway Extension to 1-16. In a study completed by CORE MPO, three alternatives were compared, and the Diverging Diamond Interchange (DOI) was found to be the best option. All three alternatives include widening or replacement of the existing bridge over 1-16. The project would begin with an Interchange Modification Report (IMR) for submittal to GDOT and FHWA, which will include a review to verify the DOI is the preferred alternative. Once the IMR is approved, a concept report will be completed with design and construction plans to follow.

- **Project Status:** The project ranked #1 and #2 during the 2020 HIP and Z230 Calls for Projects, respectively. This was a new project that was awarded HIP funds for preliminary engineering and amended into FY 2021 of FY 2018 2021 TIP and carried forward to the FY 2021 -2024 TIP.
- Administrative Modification: Slight cost increase.
- **Reason for Update:** CORE MPO re-allocated HIP funds during the FY 2021 -2024 TIP development process, affording this project phase some additional HIP funds in FY 2021.

8. PRISCILLA D THOMAS WAY (FORMERLY WHEATHILL ROAD)/ STATE ROUTE 21 (SR 21) SIGNALIZATION PROJECT

- **PI** #: TBA
- MTP Priority: Operational Improvements Set-aside
- Project description: The project is located at an existing intersection on State Route 21 (SR 21). GDOT agrees that the intersection will meet warrants and the signal will be permitted in the future. GDOT is also planning for a High Intensity Activated Crosswalk (HAWK) beacon to the south of this intersection project. The new traffic signal will also provide safe pedestrian facilities and crosswalks to supplement the HAWK. The costs associated with the project include preliminary engineering (PE), construction of a right turn lane from SR 21 onto Priscilla D Thomas Way and a new traffic signal. Additional costs associated with the project include widening of Priscilla D Thomas Way to three lanes to allow for a dedicated left turn movement onto SR 21. Costs also include relocation of existing sidewalks and construction of new sidewalks.
- **Project Status:** This was a new project that was awarded HIP funds and amended into FY 2021 of FY 2018 2021 TIP. However, it was later determined that the project sponsor Garden City is not LAP certified. No other project sponsor has been identified. Thus, the project cannot be programmed in the TIP until after Garden City is LAP certified. The awarded HIP funds have been removed from the project.

9. CITY OF SAVANNAH – TRAFFIC CONTROL CENTER

- **Project description:** The City of Savannah is relocating their operations from the city lot on Gwinnett St to a new facility on Interchange Court. This will require that the existing TCC be moved to the new site. The City is partnering with GDOT to make the new facility connected to the GDOT system to provide a more regional operation that incorporates data from the City's TCC. The costs associated with the project are for equipment, fiber installation extensions, consulting, and software to make the new operation compatible with the GDOT system. This new facility will place the City of Savannah more in line with other agencies in the Savannah MSA and allow for future growth of the system into a regional center. The new TCC will encompass approximately 2,500 square feet.
- **Project Status:** The project ranked #4 during the 2020 STBG Call for Projects. Urban attributable (Z230) funds will be used for the PE, UTL and CST (Equipment and software acquisitions and installation) phases in FY 2021.
- Amendments: Add PE, UTL, and CST phases to FY 2021.
- Reason for Update: New project for FY 2021.

10. CAT – ELECTRIC BUS CONVERSION INITIATIVE

- **PI** #: TBA
- MTP Priority: Transit Improvements Set-aside
- **Project description:** Chatham Area Transit Authority (CAT) is requesting funds to retire and replace one heavy-duty diesel transit vehicles with one zero emission, battery-powered electric transit vehicle and a fast-charger. Converting CAT's fleet to battery-powered electric vehicles will not only reduce the community's carbon footprint, but it will also reduce maintenance costs over the lifespan of the vehicles. CAT proposes to use the funding to replace the oldest and least reliable buses in its fleet, which were delivered in 2003. The EV fast-charger will be installed at one of CAT's primary transfer locations for maximum deployment flexibility. The replacement bus will be ADA compliant.

- **Project Status:** The project ranked #5 during the 2020 STBG Call for Projects. Urban attributable (Z230) funds will be used for the electric transit vehicle purchase and electric charger in FY 2021.
- Amendment: Add CST phase to FY 2021.
- **Reason for Update:** New project for FY 2021.
- Funding/Year: The funding code and funding amount for the project phase are shown below.

11. CHEVIS ROAD IMPROVEMENT PROJECT

• **PI** #: TBA

• MTP Priority: Non-Motorized Transportation Improvements Set-aside

- **Project description:** This project will consider motorized and non-motorized transportation improvements on Chevis Road from State Route 25/Ogeechee Road to Wild Heron Road. A portion of the road in the high-density area will be converted to an urban section with 5-foot sidewalks on both sides of the road. The more rural portions of the project will consider installing a 10-foot multi-purpose trail on one side of the road. Project will also consider water quality and storm water infrastructure improvements, as well as provide a safe route to access area schools and commercial businesses for non-motorized commuters.
- **Project Status:** The project ranked #1 during the 2020 Z301 Call for Projects. Chatham County is the local sponsor. Some old TAP funds have been identified by GDOT that will lapse on September 30, 2021. These are considered new revenues beyond the Z301 revenue projections for FY 2021 2024 TIP development. Part of these lapsing TAP funds will be used for the preliminary engineering phase in FY 2021. Z301 funds from the original FY 2021 2024 TIP revenue projection balance in FY 2021 will fund the rest of the PE phase. Z301 funds will also be used for other project phases in later years.

12. GARRARD AVENUE IMPROVEMENT PROJECT

• **PI** #: TBA

• MTP Priority: Non-Motorized Transportation Improvements Set-aside

- **Project description:** The Garrard Avenue Improvement Project proposes to construct operational and safety improvements for non-motorized and motorized roadway users from its intersection at Gamble Road to its intersection with Chatham Parkway, approximately 1.2 miles in length. This project will convert Garrard Avenue from a rural, two-lane roadway section without pedestrian improvements to a new two-lane, urban section with 5-foot sidewalks on both sides of the roadway. The project will also install curb and gutter as well as stormwater and water quality improvements. The project will benefit the densely populated, lower income area where many residents do not have vehicles to get to their destinations.
- Project Status: The project ranked #2 during the 2020 Z301 Call for Projects. Chatham County is
 the local sponsor. Chatham County was awarded Z301 funds for preliminary engineering in FY
 2021.

Public Participation Process

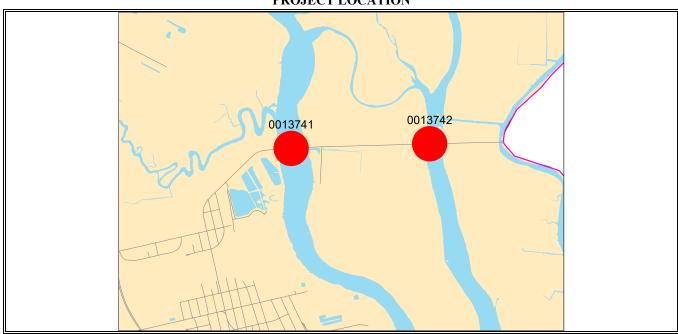

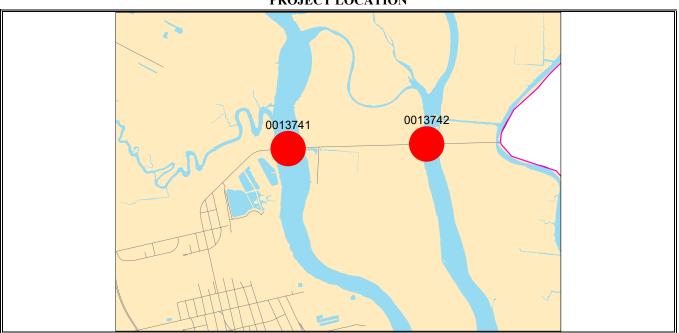

COMMENTS/REMARKS: The preliminary engineering (PE) funds programmed in FY 2017 for concept development and related activities have been authorized. The City of Savannah is the local project sponsor and is conducting preliminary engineering work through its consultant. Additional PE funds are needed in FY 2019 for reconfiguration of the 52nd Street bridge crossing and other preliminary engineering work. The most recent schedule indicates construction phase should be programmed in FY 2021. The most recent construction cost estimate is \$4,405,623. The project ranked #2 during the December 2018 – January 2019 Z301 Call for Projects. City of Savannah was awarded \$155,583 of Z301 funds for PE in FY 2019 and will provide the 20% local match.
