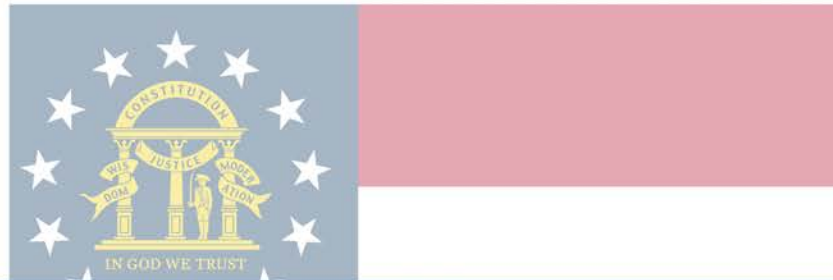

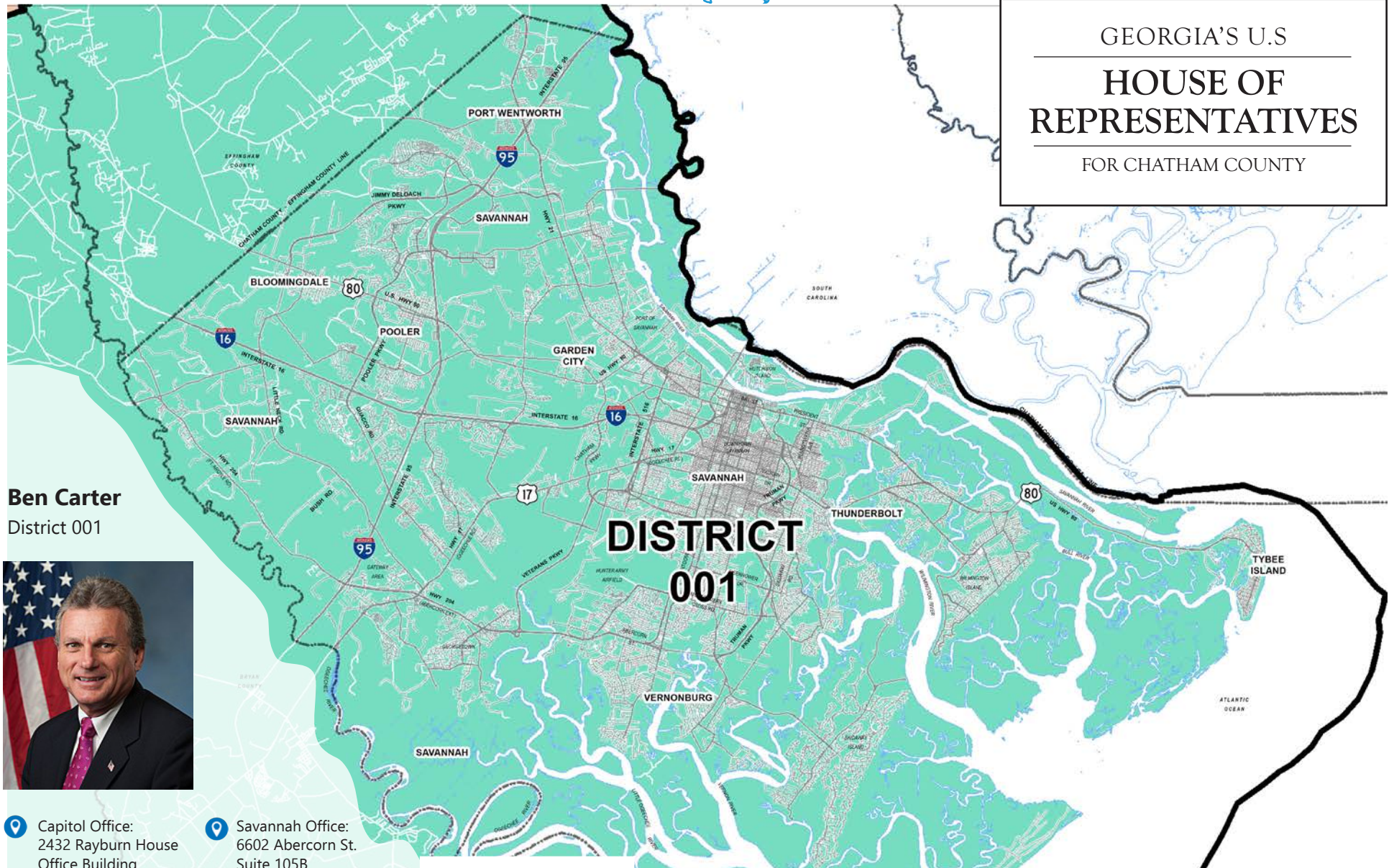

## Public Service Commission

The Public Service Commission was founded in 1879 for the regulating of the railroad and freight operations, rates and services. Today the Georgia Public Service Commission has the responsibility to decide fair and reasonable rates for all services that fall under its jurisdiction. It ensures that consumers receive the best possible value in telecommunications, electric and natural gas services while it balances the citizens' need for dependable and fair rates with utilities need to make reasonable return on their investment. The Public Service Commission serves to protect the consumers as it abides by legal standards for rate setting.

The Commission includes 5 elected Commissioners and is supported by approximately 94 staff members.

## Georgia's Legislative Districts:

Formed in 1777 the legislature, also formally known as the Georgia General Assembly and precedes the United States Congress. At its' inception, the legislature was comprised of one house, but it evolved in 1789, composing of a House of Representatives and a Senate. Although the House of Representatives and the Senate operate with related powers, some exceptions apply. Appropriation bills must originate in the House and confirmation of the Governor's appointments rely on the Senate, but both bodies must be in agreement before any bill is made into a law. Two-year terms apply to both the 180 member House of Representatives and the 56 members of the Senate. Every member of each body is elected concurrently.
