

Resolution to Amend the FY 2015 – 2018 Transportation Improvement Program of the Coastal Region Metropolitan Planning Organization (CORE MPO)

WHEREAS, the Coastal Region Metropolitan Planning Organization (CORE MPO) desires to adopt amendments to the FY 2015 - 2018 Transportation Improvement Program (TIP) for the CORE MPO transportation planning area; and

WHEREAS, the proposed TIP amendments include the following:

- PI# 0013741, SR 25/US 17 @ Savannah River in Port Wentworth program this new bridge project (preliminary engineering phase and right-of-way phase) to the TIP subsequent to its amendment into the 2040 Metropolitan Transportation Plan;
- PI# 0013742, SR 25/US 17 @ Middle River in Port Wentworth program this new bridge project (preliminary engineering phase and right-of-way phase) to the TIP subsequent to its amendment into the 2040 Metropolitan Transportation Plan; and

WHEREAS, CORE MPO has completed a 15-day public review and comment period for the TIP amendments according to the Participation Plan and incorporated all received comments; and

WHEREAS, CORE MPO would like to complete the TIP amendment process to incorporate the project programming updates.

NOW, THEREFORE, BE IT RESOLVED THAT, the Coastal Region Metropolitan Planning Organization approves the proposed amendments to the FY 2015 - 2018 Transportation Improvement Program as shown in the summary of TIP amendment report with any corrections based upon the motion of October 28, 2015.

Agenda Item: Amendment to FY 2015 – 2018 Transportation Improvement Program

Summary: The Transportation Improvement Program (TIP) is the MPO's short-range programming document and is a staged, multi-year listing of surface transportation projects proposed for federal, state and local funding within the metropolitan area. The TIP may be modified in accordance with the procedures outlined in the adopted Participation Plan by resolution of the CORE MPO Board if priorities, area goals, project schedules or funding levels change. The CORE MPO's FY 2015 - 2018 TIP was adopted by the MPO Board in August 2014. A series of administrative modifications and TIP amendments have been processed for various projects since the adoption of the TIP.

> In August 2015 CORE MPO received a request to amend the 2040 Metropolitan Transportation Plan (MTP) and the FY 2015 - 2018 TIP from the Georgia Department of Transportation (GDOT) for two bridge replacement projects - SR 25/US 17 @ Savannah River in Port Wentworth, and SR 25/US 17 @ Middle River in Port Wentworth.

According to the STIP/TIP amendment process outlined in the Participation Plan, the TIP amendment process requires public review and comment and response to all comments either individually or in summary form.

In order to process the proposed TIP amendments, CORE MPO advertised a fifteen (15) day public comment period in the Savannah Morning News on Sunday, October 11, 2015. The notice has been sent to the local news media and the consultation agencies as well as neighborhood associations, and posted on the CORE MPO website. The comment period starts on October 13, 2015 and closes on October 27, 2015. One public hearing has also been advertised - it will be held in conjunction with the CORE MPO Board meeting on October 28, 2015.

It should be noted that the Transportation Improvement Program must be consistent with the current Metropolitan Transportation Plan. Before revisions can be made to the FY 2015 - 2018 TIP, MTP/TIP consistency must be checked. CORE MPO is processing the MTP amendments for these two projects in conjunction with the TIP amendments. As required by the Federal Highway Administration (FHWA), an addendum to the current 2040 MTP has been developed to document the consistency check as a part of the October 2015 TIP amendments.

The following summarizes the October 2015 TIP amendments.

SR 25/US 17 @ SAVANNAH RIVER IN PORT WENTWORTH

- *PI* **#**: 0013741
- *MTP Priority*: Preliminary engineering (PE), right-of-way (ROW) and construction (CST including utility) phases are being amended to move from Cost Band Three (2031 2040) to Cost Band One (2015 2020) of the 2040 Total Mobility Plan.
- **Project description:** Replace the bridge at SR 25/US 17 @ Savannah River in Port Wentworth. Specific bridge design is to be developed.
- Amendment: Add a new project to the FY 2015 2018 TIP.
- **Reason for Amendment:** Addition of a new project to the TIP is considered an amendment.




