Sec. 8-3025. Regulations as to uses.

Within the various zoning districts established by this chapter and designated on the zoning map, no building, structure or land shall be constructed, erected, altered, used or maintained, except as provided in the following schedules, number and entitled as follows:

(a) Provisions regarding uses in C districts and R districts. Permitted uses in the various "C" districts and "R" districts are identified by the letter "X" in the appropriate column of the use schedule. Uses permitted subject to the approval of the Board of Appeals in the various C districts and R districts are indicated by the letter "B" in the appropriate column of the use schedule. Uses marked with a "B1" shall require the submittal of a site development plan to the Metropolitan Planning Commission for review and approval when the use contains three acres or more. The plan shall identify all proposed buildings, parking areas, driveways, curb and median cuts, proposed buffers, and such other information as may be required by the Metropolitan Planning Commission for its review.
