Each year, the UPWP details the staff budget and work projects expected to be undertaken by the MPO in support of the federally mandated 3-C (Continuing, Cooperative and Comprehensive) transportation planning process.

Appendices E and F contain summaries of comments and responses that were received.

Adoption of the FY 2017 UPWP by the CORE MPO Board at the March 9, 2016 meeting will continue the federally required 3-C transportation planning process, thereby ensuring continued eligibility for federal transportation funds.

6. Amendments to the 2040 Total Mobility Transportation Plan

Ms. Wykoda Wang with the CORE MPO explained that in December 2015 CORE MPO received a request from the Georgia Department of Transportation (GDOT) and the Chatham County Engineering Department to amend the 2040 MTP and the FY 2015 - 2018 TIP for three projects. This request entails the following changes:

- 1) include all of the phases of I-16 Widening from I-95 to I-516 to Cost Band One of the 2040 MTP;
- 2) include all of the phases of I-95/I-16 Interchange Reconstruction to Cost Band One of the 2040 MTP;
- 3) have I-16 Widening and I-95/I-16 Interchange Reconstruction as one design-build project in project development and letting:
- 4) release M230 funds from the Ogeechee Road Widening right-of-way phase for use by the I-16 Widening preliminary engineering phase; and
- 5) use all state funds to develop the Ogeechee Road Widening for expedited project delivery.

At the December 2015 meeting the CORE MPO Board authorized staff to conduct further analysis to test fiscal feasibility of incorporating these changes regarding the 2040 MTP and the FY 2015 - 2018 TIP.

The staff recommendation was for CAC endorsement of the Amendment to the 2040 Total Mobility Transportation Plan.

III. Status Reports

8. Regional Traffic Management Center Symposium

Ms. Stephanie Rossi, with the CORE MPO, stated the Traffic Management Center Symposium was on February 11 and included 4 speakers, David Montanye with Cobb County, Chuck Bailey with Gwinnett County, John Hibbard with Georgia Department of Transportation and Jeff Hocmuth with CDM Smith. She noted that the symposium got some news coverage.

Part of the study is to explore the benefits and strategy to implement a TMC here. Phase I was peer tours and inventory. Phase II includes the goals, objectives, strategies and strategic plan that includes steps and funding. The study will be completed before June 2016. Regarding a question about when a Traffic Management Center might actually get built, Ms. Rossi said that is unknown. The current effort is to get the right people interested in the short-term, mid-term, and long-term recommendations for making it happen.

Ms. Wykoda Wang, with the CORE MPO, stated The draft deliverables for the Freight Transportation Plan Phase II have been completed and are available for review on the CORE MPO's

website. CORE MPO staff is inviting the MPO Board and advisory committee members to review the reports and provide input. Staff expects to finalize all of the reports and have them adopted by the CORE MPO Board in April 2016.

Mr. Tom Thomson, with the CORE MPO, said the study, as a combined effort of the MPO/MPC and the City of Savannah, has focused on parking as an important public resource and service but views it as part of a larger transportation and mobility system for central Savannah. Managing parking goes hand in hand with providing a range of travel options to, from and within the city center. He reviewed the strategies outlined in the study, and announced the times and locations for two identical open houses scheduled for March 3 and March 4.

11. Update on Victory Drive Phase III

Mr. Thomson stated that Phase I (an overview of entire corridor) is complete and the Phase II recommendations (focused on the segment from Ogeechee Road to MLK, Jr. Boulevard) were presented to the MPO in December. More information on those phases is available on the web page.

Phase III is going to look at the segment of Victory Drive from Bee Road to Shuptrine Avenue (just east of Skidaway Road). He reviewed the tasks proposed in Phase III.

He noted which other segments of Victory Drive could become the focus of Phase IV and asked the CAC members each to indicate their rankings.
