#### 3. Deconstruction

Ms. Fenwick stated she believes it has come a long way. Requested Board so share their thoughts.

Mr. Williams shared regarding deconstruction for salvage versus relocation. Deconstruction: write a definition of deconstruction and add to Ordinance. Also 'relocation' and 'demolition' for definition section of Ordinance. 3.18.8

Per the Ordinance, it would be viewed as new construction. It cannot be moved from one district to another, not delisted unless it loses all its integrity.

Staff should be contacted prior to building relocation. Building plans should be submitted prior to relocation.

Language should be clarified. Suggestions presented at next meeting and decide on verbiage.

Ms. Bowley presented her thoughts about adding 'deconstruction' wherever the word 'demolition' occurs. Trying to provide additional options other than demolition.

Ms. Fenwick stated there needs to be a review of the City's 'next steps' document. Somehow have owner have knowledge they are in a historic structure and how to access the Ordinance for permitted/restricted changes.

Marketing campaign to notify necessity of permission before altering structure. Notify new owners through utility mailings in historic districts. Grants for sign designation. Bring examples to next meeting.

Notify residents of City of Savannah Home Repair Program for assistance.

Street signs to indicate the various historic districts, as City replaces signs. Brown signs refer to cultural/historic neighborhoods. Neighborhood symbols, plaque programs, for insignia flag. Grants.
