Ms. Jackie Jackson, the Director of Comprehensive Planning, presented the following information:

As previously discussed with the Board, MPC staff has completed an update to Chatham County and the City of Savannah's comprehensive plan intended to lay out a road map for the community's future. The draft was developed through a very public process of involving the general public and stakeholders to provide feedback and suggestions on key decisions that will shape the future of our community.

In addition, the Comprehensive Plan is intended to create an environment of predictability for business and industry, investors, property owners, tax payers and the general public. The plan also helps local governments to recognize and then implement important economic development and revitalization initiatives.

The Comprehensive Plan must include required plan elements, however, the MPC goes beyond these minimum required elements and enriches the Comprehensive Plan with other elements to ensure the document is fully applicable to our community. These include:

- Economic Development
- Land Use
- Transportation
- Housing
- Natural Resources
- Historic & Cultural Resources
- Crime
- Health
- Education
- Service Delivery Strategy

The 2016 update must be approved and adopted by the MPC, Savannah City Council and Chatham County Commission. Lastly, the plan must be approved by the Georgia Department of Community Affairs by October 31, 2016.

Ms. Jackson will again make a short presentation detailing the key activities and input this far as well as presenting the Draft Comprehensive Plan for approval at the next MPC meeting on August 9, 2016.
