1. Approval of the Oct. 25, 2017 CORE MPO Board Meeting Minutes

The minutes of the October 25, 2017 meeting of the CORE MPO Board were approved as written.

2. Safety Targets

Ms. Stephanie Rossi gave a presentation about the proposed Safety Targets, required by MAP-21 and the FAST Act. Targets are to be selected for five measures specified by the US DOT: Number of Fatalities; Rate of Fatalities per 100 million vehicle miles traveled (VMT); Number of Serious Injuries; Rate of Serious Injuries per 100 million VMT; Number of Non-motorized Fatalities and Serious Injuries. She said the MPO may either adopt its own targets or support the targets that have been adopted by the Georgia Department of Transportation (GDOT). The state's targets are to be under the trend lines for each measure, based on rolling five-year averages. Targets are adopted each year, and thus the MPO will have opportunities in the future to reconsider its targets, whether supporting the state targets or adopting its own. MPO staff recommended that the CORE MPO Board support the GDOT targets at this time. Ms. Rossi reviewed the considerations behind the recommendation. The deadline for the MPO's target selection is February 27, 2018. She added that, in the near future, the MPO will consider how to incorporate their chosen targets into the Metropolitan Transportation Plan (MTP) and the Transportation Improvement Program (TIP). There were no questions or comments. A motion was made and seconded to support the GDOT Safety Targets via the CORE MPO Board resolution. The motion passed with none opposed.

GDOT -- Mr. Byron Cowart reviewed the status of projects on the state's list. Mr. Tom McQueen noted that the dates on the sheet will be updated once the Governor signs the latest Transportation Improvement Program (TIP).

Chatham County -- Mr. Leon Davenport report that Benton Blvd. project is ready for ROW acquisition. The Quacco Rd. project is going into acquisitions. On the Skidaway Rd. project, they are going ahead with drainage improvements on the segments where they have permits already.

City of Savannah -- Mr. Mike Weiner said that an Environmental Impact Statement (EIS) is being prepared for Project DeRenne. On the LaRoche Ave. project, the ROW phase will begin once the Notice to Proceed is received. On the Gwinnett St. project, the ROW plans are being finalized. The signal at Highlands Blvd. and Jimmy DeLoach Pkwy. began operation in October.

City of Garden City -- Mr. Ron Feldner reported that Chatham Pkwy. should be ready for normal traffic operations by the end of January, 2018.
